1. **Chaklala Cantonment Board, Rawalpindi** is undertaking construction of CB Raheel Sharif Medical & Dental College, Rawalpindi and is eligible to make payments under the contract(s) for which this Invitation for Pre-qualification is issued.
2. **Chaklala Cantonment Board, Rawalpindi** hereinafter the Employer intends to prequalify constructors for the following Works under this project:  
**Construction of Medical College Blocks (Block-A and Block-B), Cafeteria & Animal House at Jhelum Road near Al-shifa Trust Eye Hospital, Chaklala Cantt Rawalpindi**
3. It is expected that Invitation to Bid will be issued till **15<sup>th</sup> July, 2019**.
4. Pre-qualification is open to constructors/joint ventures of constructors who are registered with PEC in Category **(C-2 Or Above)** for Construction and Operation of Engineering Works, described in para 2 mentioned hereinabove. Applications may be submitted for pre-qualification for the above Works.
5. Appropriate category PEC registered constructors may obtain the prequalification Documents from the office of the Employer, at  
**Chaklala Cantonment Board, Murree Road, Saddar Rawalpindi, Ph No. 051-9272087, Fax No. 051-9270150** or may request to send the same through mail at the specified address.
6. The request must clearly state Request for Pre-qualification Documents” for **Construction of CB Raheel Sharif Medical & Dental College, Rawalpindi**. The documents are available for a non-refundable fee of **Rs. 1000/-**. The documents if requested by mail will be promptly dispatched by registered mail for which cost of mail i.e. **Rs. 1000/-** will be borne by the Applicant, however, under no circumstances the Employer will be responsible for late delivery or loss of the documents so mailed.
7. A minimum requirement for pre-qualification will be to have successfully Completed the requirement as per qualification criteria

10. Applicants will be informed, in due course, of the result of the evaluation of applications. Only the firms of constructors and joint ventures prequalified under this process will be invited to bid.

## INSTRUCTIONS TO APPLICANTS

### 1. Submission of Applications

1.1. Applications for pre-qualification (one original and two copies) must be received in sealed envelopes to be delivered by hand or through registered mail at the address;

1.2. The project is named as ‘CB Raheel Sharif Medical and Dental College, Chaklala Cantonment’ and is hereinafter referred to as the Project.

1.3. Application received later than the date mentioned in para 1.1 shall not be entertained.

1.4. The name and mailing address of the Applicant shall be clearly marked on the left hand-side of the envelope.

1.5. The applications shall be prepared in the English language only.

1.6. The Applicants must respond to all questions and provide complete information as advised in this document. Any lapse to provide essential information would result in disqualification of the Applicant.

1.7. The clarification meeting regarding the project shall be held in the office of the Chaklala Cantonment Board at the time and date to be communicated after the receipt of applications.

### 2. Qualification Criteria

#### 2.1. General

2.1.1. The Employer reserves the right to waive minor deviations, if these do not materially affect the capability of an applicant to perform the contract. Sub-contractor’s experience and resources shall not be taken into account in determining the Applicant’s compliance with the qualifying criteria. However, Joint Venture experience & resources shall be considered.

Consortium or Association of firms will be considered for similar treatment as in case of Joint Venture.

2.1.2. Pre-qualification status shall be decided on the basis of Pass/Fail basis. The applicant must secure at least 50% score in each category.

### **3.3 Joint Venture (JV)**

3.3.1 Joint Venture must comply with the following requirements:-

a) Following are minimum qualification requirements:-

- i) The lead partner shall meet not less than 50 percent of all qualifying criteria given in paras 3.2 and 3.5 heretofore.
- ii) Each of the partners shall meet not less than 30 percent of all the qualifying criteria given in paras 3.2 and 3.5 heretofore.
- iii) The joint venture must collectively satisfy the criteria of paras 3.2, 3.3 and 3.4, for which purpose the relevant figures for each of the partners shall be added together to arrive at the JV's total capacity. Individual members must satisfy each of the requirements of paras 3.5 and 3.6 heretofore

b) Any change in a prequalified JV after prequalification, shall be subject to the written approval of the Employer prior to the deadline for submission of bids. Such approval may be denied if:-

- i) Partner(s) withdraw from a JV and remaining partners do not meet the qualifying requirements;
  - ii) The new partners to a JV are not qualified individually or as another JV; or
  - iii) In the opinion of the Employer, a substantial reduction in competition would result.
- c) Bid shall be signed by all members in the JV so as to legally bind all partners, jointly and severally, and any bid shall be submitted with a copy of the JV agreement providing the joint and several liability with respect to the contract.

The prequalification of a JV does not necessarily prequalify any of its partners individually or as a partner in any other JV or association. In case of dissolution of a JV, each one of the constituent firms may pre qualify if they meet all the prequalification requirements and any partner of J.V has requested/shall request for the same and then his prequalification shall be subject to the written approval of the Employer.

### 3. Conflict of Interest

- 3.1. The Applicant (including all members of a JV) must not be associated, nor have been associated in the past, with the consultant or any other entity that has prepared the design, specifications, and other prequalification and bidding documents for the project, or was proposed as Engineer for the contract, over the last five years.
- 3.2. Any such association may result in disqualification of the Applicant.

### 4. Updating Prequalification Information

- 4.1. Participants shall be required to update the financial, personnel and equipment information used for pre qualification at the time of submitting their bids, to confirm their continued compliance with the qualification criteria and verification of the information provided at the time of prequalification. A bid shall be rejected if the Applicant's qualification thresholds are no longer met at the time of bidding.

### 5. Other Factors

- 5.1. Only firms and JVs that have been pre-qualified under this procedure shall be invited to bid. A qualified firm or a member of a qualified JV may participate only in one bid for the contract. If a firm submits more than one bid, singly or as a JV, all bids including that bidder will be rejected. This rule will not apply in respect of bids which include specialist sub-contractors who are used by more than one bidder.
- 5.2. The Employer reserves the right to;
  - 5.2.1. Amend the scope and value of any contract(s) to be bid, in which event the bidder(s) will only bid among those pre-qualified bidders who meet the requirements of the contract(s) as amended. However, the Employer has to review the disqualified bids who originally do not meet the specified criteria for Prequalification.
  - 5.2.2. Reject or accept any application; and
  - 5.2.3. **Cancel the prequalification process and reject all applications.**
- 5.3. The Employer shall neither be liable for any such actions nor be under any obligation to inform the Applicant of the grounds for rejection, however, may be debriefed if solicited.
- 5.4. Applicants will be informed in writing by fax or mail within 42 days of the date for submission of applications (para 8 of Chapter 2.0,
